

# YOUTH AND ADOLESCENT ADDICTION SPECIALIST LICENSED PRACTITIONER (YAAS-LP)

This endorsement is specific to licensed practitioners of the healing arts, specializing in youth treatment. It recognizes competencies that are beyond the requirements of the primary license in the area of addiction and its impact on adolescent development. The specialty endorsement program is only available to licensed professionals. Must hold a current license as a licensed practitioner of the healing arts (Physicians, Physician Assistants, Nurse Practitioners, Registered Nurses, Registered Pharmacists, Licensed Clinical Psychologist (LCP), Licensed Clinical Social Worker (LCSW), Licensed Professional Clinical Counselor (LPCC), and Licensed Marriage and Family Therapist (LMFT) and licensed-eligible practitioners working under the supervision of licensed clinicians) to apply for the YAAS-LP.



# YOUTH AND ADOLESCENT ADDICTION SPECIALIST CERTIFIED COUNSELOR (YAAS-CC)

This endorsement is specific to certified alcohol drug counselors specializing in youth treatment. It recognizes competencies that are beyond the requirements of the primary credential for alcohol drug counselors. It demonstrates competency in the treatment of youth and adolescents. The specialty endorsement program is only available to Alcohol/Drug Credentialed Counselors, or Licensed Alcohol Drug Counselors in states where licensure is conferred.

# YOUTH AND ADOLESCENT ADDICTION SPECIALIST LEGACY CANDIDATE

Legacy credential is a process by which individuals are granted credentials without being required to meet a formal coursework requirement. Legacy applications allow applicants to meet the requirements for Legacy (previously termed "Grandfathered") credential by providing documentation based on their previous relevant experience, other credentials, and training and accomplishments in the field.

# GETTING YOUR SPECIALTY ENDORSEMENT CREDENTIAL HAS NEVER BEEN EASIER

The process for earning a credential through CCAPP can be summed up in a few steps:

- 1. Determine your eligibility
- 2. Create an account through Certemy
- 3. Submit required documentation
- 4. Get approval from CCAPP Credentialing
- 5. Receive your certificate and badge of recognition from CCAPP

# **CREDENTIAL ELIGIBILITY**

To qualify for CCAPP's specialty credentials and endorsements, candidates must meet all of the eligibility requirements for their chosen specialty. CCAPP's fourteen specialty credentials have different eligibility requirements. Additionally, all candidates and certificates must abide by the CCAPP Code of Conduct and the CCAPP Code of Ethics.



# ACCEPTABLE ACCREDITATION OF COLLEGES AND UNIVERSITIES

# Is my school CCAPP approved?

All education content and applications for approval are reviewed autonomously by the CCAPP Education Institute (CCAPP-EI), which is the education board for the California Consortium of Addiction Programs and Professionals (CCAPP), and CCAPP Credentialing. CCAPP-EI exclusively reviews educational content to assure it meets the requirements for credentials and recommends approval, denial, or deferment to CCAPP. For a school's curriculum to be approved as meeting the educational requirements for credentials, the school does not have to be on the "Approved California Alcohol & Drug Program Schools" list. If someone wants to attend an institution, not on the "CCAPP Approved California Alcohol & Drug Program Schools" list, call the CCAPP office to see if the institution has been approved. If the school or program has not been approved in the past, please review the curriculum to see if it meets CCAPP requirements.



### **CCAPP Education Providers**

All education content used for CCAPP credentials are reviewed autonomously by the CCAPP Education Institute, which is the education board for CCAPP Credentialing. The CCAPP Education Institute exclusively reviews educational content to assure it meets the requirements for credentials and recommends approval, denial, or deferment to CCAPP Credentialing.

## THE FOUR DOMAINS OF STUDY FOR THE YAAS

# THE FOUR DOMAINS OF STUDY FOR THE YAAS

The following core areas are used to assist in the review of an applicant's education and work experience. A minimum of 50 hours are required in these domains for both education and work experience as indicated on their logs. Please use this list as a guide in recording your hours for education and experience. For Legacy applicants, this requirement is waived but must show 50

hours of education and work in at least ONE or more of the following domains.

# Adolescence as a Cross-cultural Experience - 15 hours

This emphasizes the shared experience that adolescence entails for people across all cultural backgrounds. Essentially, we are looking to define the answer to this question: What is the adolescent experience?

# **Propensity for Use and Psychological Effects - 15 hours**

This explores how addictive drugs impact the adolescent brain and what kind of effects it has on this age group compared to adults.

# **Biophysical Development and Adolescence - 10 hours**

This domain's coursework will take a deep dive into the stages of development and what truly defines each age category. The goal of this curriculum is to look at how we can best define each stage of development so professionals understand the nuanced differences.

# **Best Strategies to Engage Youth - 10 hours**

This lets professionals study what best works for different people in successfully engaging youth. Understanding the best approach methods could vary from person to person and the methods they implement can sometimes be unique to them. Being able to explore some of these effective ideas is vital to collective strategies when successfully working with youth.

# **50 HOURS TOTAL**

# **EXAMPLES OF EDUCATION AND EQUIVALENCY**

## WAYS TO EARN EDUCATION

A total of **50 hours** of training or education in the following areas must be documented:

- Adolescence as a Cross-cultural Experience (15 hours)
- Propensity for Use and Psychological Effects (15 hours)
- Biophysical Development and Adolescence (10 hours)
- Best Strategies to Engage Youth (10 hours)

Education can be obtained in a variety of ways. They are divided into the following categories:

# Category A | Attendance

Attending clinics, conferences, seminars, workshops, or live-streamed events. The content provided must be related to the four domains for the YAAS and be consistent with CCAPP credentialing standards.

# **Category B | Share Your Expertise**

- » Work Experience | Working any number of years as a licensed practitioner or credentialed counselor.
- » Presentations | Participation as a speaker or panelist at clinics, conferences, seminars, workshops, etc.
- » Publications | Published works in which the individual serves as an author or co-author focused on any of the four domains.

# Category C | Education

- » CCAPP Education | Successfully completing courses with CCAPP Education that fall into the four domains.
- » Earning CEHs with CCAPP-approved providers | Must be classified for the amount of hours for each domain.

## **WORK EXPERIENCE REQUIREMENTS AND CONTINUING EDUCATION**

### **EXPERIENCE REQUIREMENTS**

Work experience for this specialty credential is vital to the comprehension and expertise of the individual's competency in engaging with youth in the field of SUD and addiction. Here are examples of various ways to demonstrate competency through work experience and history:

# Who Can Attest to My Work Experience?

The applicant must provide a letter from the facility director or manager, or other documentation from the facility at which he or she was employed (or volunteered), that attests to the specialty services offered and the experience hours the applicant has provided at the program. A statement of recommendation from a supervisor must also be included or uploaded as a separate document. All experience must be accrued within ten years of the date of application. Must be in letterhead with appropriate dates of employment, and must be signed by supervisor.

# **Legacy Experience Requirements**

The applicant must provide a copy of their resume and/or education experience (50 hours of education in any domain OR 1,000 hours experience).

## **Practicum vs. Work Experience**

- » Work Experience | Working any number of years as a licensed practitioner or credentialed counselor.
- » **Practicum** | Supervised work experience designated as field practicum.

# How Do I Provide 6 Hours of Continuing Education?

- » CCAPP Academy | Successfully completing 6 hours of adolescent-focused courses with CCAPP Academy that fall into the four domains.
- » Earning CEs with CCAPP-approved providers | The applicant must provide documentation of their education on the online application for the required hours in each domain.



# **HOW TO MAINTAIN YOUR ENDORSEMENT CREDENTIAL**

## INTRODUCTION

#### YOUR DISTINGUISHED ACHIEVEMENT

Holding a CCAPP credential demonstrates that you are a dedicated professional. Your CCAPP specialty credentials and endorsements indicate you have specialized knowledge, skills, and abilities towards your career.

#### AN ONGOING COMMITMENT

It is important to remain competent in your field and continue to be educated about the constantly changing world of substance use disorder counseling. Maintaining your credential shows your commitment to your career, and ensures you are equipped to do your job to the best of your ability.

# MAINTAINING YOUR CREDENTIAL

No matter which credential you hold, there are vital parts to maintaining your credentials. There are vital parts to maintaining your credentials.

### TO GET A RENEWAL:

Complete and report a certain number of Continuing Education Hours (CEHs) and pay the recredential fee.

## WHY DOCUMENTATION IS REQUIRED

There are three certifying organizations with authority to certify counselors for the purpose of working in a facility licensed or credentialed by the Department of Health Care Services. Counselors may choose, at any time, to transfer credential to another organization. Be aware that phrases such as "transitioning to" or promises of credential at a future date are not valid for documenting credentialed status with the Department of Health Care Services. You must have written documentation attesting to your CURRENT, not future status, to comply with regulations. All CCAPP credentials are valid in the State of California. All transfers accepted by CCAPP are provided with documentation to meet state regulations within 30 days of receipt of the application.

#### THE RENEWAL PROCESS

Renewed will be based on each applicant's individual license or credential. Renewal will require uploaded verification every renewal period if you are still licensed or credentialed. It will also require six continuing education units in the four domains that can be completed anywhere and are trainings that the applicant has attended that enhance professionalism. Online CEs must not exceed eight hours in a single day.

# **BREAKING DOWN THE CEH (Continuing Education Hours)**

#### WHAT IS A CEH?

CEH stands for Continuing Education Hours, and it is the way we measure your continuing education. CEHs range across a variety of topics. You can earn CEHs in various ways such as attending in-person or virtual events, taking CCAPP-approved courses, or taking and passing a quiz.

#### **CCAPP IS A CE PROVIDER**


As a CEH provider, CCAPP Education offers top-quality training for multiple credential boards. Our courses are meticulously designed to exceed industry standards and deliver the latest insights, making us the ideal choice for professionals aiming to enhance their expertise.

CCAPP is an approved provider for the following credential boards: CCAPP, BHAP, CAMFT, NBCC, NAADAC, CADTP, Tennessee Credential Board (TCB), ADACBGA, Connecticut Credential Board (CCB), MHACBO Provider.

#### **HOW ARE CEHS CALCULATED?**

The amount of CEHs you earn is generally based on the number of hours you spend to complete an activity or event. Not all CE activities is based on actual clock hours. There are exceptions, such as college or university courses, where one semester credit hour equals \_\_\_ CEHs. For example:

- » 3-unit, semester-long course equals 45 hours (CEHs)
- » 4-unit, quarter-long course equals 12 CEHs

#### ACCEPTABLE CONTENT FOR CEHS

Only continuing education content that relates to the scope of practice and contents of a CCAPP specialty credential will be accepted. If you have questions about the acceptability of a particular activity's content, contact CCAPP Credentialing prior to engaging in the activity for credit.

## **ETHICS COMPLIANCE**

# ETHICS FOR ADDICTION COUNSELORS

All professionals who are registered, credentialed, or licensed by CCAPP sign two ethics agreements, the State of California AOD Counselor Code of Conduct and the CCAPP Code of Conduct for Credentialed Alcohol and Drug Professionals, when completing an application. These agreements are legally binding contracts that set forth expectations and consequences regarding ethical behavior for the profession. Consequences for violating these agreements are contained in California Law and Regulation, as well as the Uniform Disciplinary Guidelines sanctions matrix. CCAPP can apply sanctions that range from warnings and instructions, to revocation for ANY violation of either ethics agreement.

It is incumbent upon all credentialed professionals to read and understand the State of California AOD Counselor Code of Conduct and the CCAPP Code of Conduct for Credentialed Alcohol and Drug Professionals and to read and understand any updates made to these agreements.


### **ANNOUNCEMENTS**

The CCAPP Code of Conduct, the CA Code of Conduct, the Uniform Disciplinary Guidelines, and the Ethics Complaints Procedures have been amended. Read these items carefully as they govern standards and procedures for disciplining credentialed counselors in California. Each becomes effective September 1, 2019. To view the previous agreements, Contact ethicscomplaints@ccapp.us.

Please note that the Uniform Disciplinary Guidelines now allow the Ethics Committee to apply sanctions that may be greater or less than the previous guidelines. Also, note that all ethics cases will be communicated using standardized written notifications of alleged violations and standardized written notices of findings.

- » **Professional Letter of Support** (It is required to submit one typed, dated, and signed recommendation letter from a credentialed or Licensed professional with the YAAS-LP and YAAS-CC. The letter must be from a colleague, a supervisor, or an instructor. It must attest to the applicant's character and competency. Letters must be signed originals and dated within 60 days of submission.)
- » **Supervised Education Requirement** (25 hours of supervision by an individual knowledgeable in adolescent and youth substance use disorder counseling by a YAAS-LP and YAAS-CC)
- » Education Requirements (50 total hours of education must be taken from CCAPP-approved providers. 50 of these hours must be specific to the YAAS domains. Education can be obtained at colleges and universities, online, at workshops and trainings, and through CCAPP Academy. All education must be from a CCAPP-approved provider/school. Copies of certificates of completion, transcripts, or other proof of attendance are required)

#### » Current Credential or License
